Invitation for Online Bids for the **Dharapaani Dhakawang Moterale Road Strengthening Works**

1. Bhumikasthan Municipality invites electronic bids from Nepalese eligible bidders for the construction of **Dharapaani Dhakawang Moterale Road Strengthening Works** under National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information and inspect the bidding document at the office of Bhumikasthan Municipality, Arghakhanchi, Arghakhanchi, Lumbini Province, Nepal or may visit PPMO website www.bolpatra.gov.np/egp.
3. Bidder chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp, upon payment of a non-refundable fee of NRs.3000.
4. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at Bhumikasthan Municipality, Arghakhanchi
6. Lumbini Province, Nepal at 18-04-2022 13:00 hours.
7. electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 29-04-2022 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 29-04-2022 13:00 at the office of Bhumikasthan Municipality, Arghakhanchi, Lumbini Province, Nepal.
9. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 95000.0, which shall be valid for 30 days beyond the validity period of the bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
